

Terms and Conditions

Updated March 2015

The **Brekhman Research Library** ("Library" or "Library Service") and Sunrise Global Trading, LLC ("Sunrise") specify the following Terms and Conditions on which Library and Sunrise offer you access to our website ("Site"). **Please read these terms carefully before using this site.**

1. Acceptance of terms and conditions through use

By registering or using the Library Service ("Service"), or accessing any Library or Sunrise website, you signify your agreement to all of the terms, conditions, and notices contained or referenced herein ("Terms and Conditions"). Library and/or Sunrise reserves the right to update or revise the Terms and Conditions at any time, provided, however, that **Paragraph 16. Arbitration and Dispute Resolution** cannot be changed to eliminate our agreement to settle any claim or controversy exclusively by arbitration. Your continued use of the Site following the posting of any changes to the Terms and Conditions constitutes acceptance of those changes.

2. Privacy

These Terms and Conditions expressly incorporate by reference and include the Site's Privacy Policy and any guidelines, rules, additional terms or disclaimers that may be posted and updated on the Site or on notices that are sent to you. If you do not agree with these Terms and Conditions, please do not use the Site.

3. Permitted Use

You may use the Library website for your personal or academic research activities. Any other use, including the reproduction, modification, distribution, transmission, republication, display, performance, re-hosting, tampering, framing, or embedding of this site or its content or tools, or any commercial use whatsoever of this website or its content or its tools, is strictly prohibited without our prior written consent.

4 Changes

Library and/or Sunrise reserves the right to change, modify, add or remove portions of these Terms and Conditions in its sole discretion at any time and without prior notice. Please check these Terms and Conditions periodically for any modifications. Your continued use of the Site following the posting of any changes will mean that you have accepted and agreed to the changes.

5. Content and Limitations on Use
